DURING THE YEAR ENDED JUNE 30, 2020, 4,400 PRE-KINDERGARTEN, KINDERGARTEN, AND 1ST GRADE STUDENTS BENEFITED FROM THIS PROGRAM. IN 2019, 4,175 PRE-KINDERGARTEN, KINDERGARTEN AND 1ST GRADE STUDENTS BENEFITED FROM THIS PROGRAM. BENCHMARKS INCLUDES THE EXTRA DOSAGE COMPONENT, WHICH PROVIDES WELL-TRAINED EXTRA DOSAGE INSTRUCTORS IN FIRST GRADE CLASSROOMS TO PROVIDE ADDITIONAL SMALL GROUP INSTRUCTION, AT THE SAME TIME THE TEACHER IS DOING SMALL GROUP INSTRUCTION IN THE SAME ROOM.
